
Poppy Seed Update

These poppy seeds are tasty and have a good crunch to them. Mine had substantial plant matter in all 3 bags, so bakers probably want to sift the seeds to keep plant matter out of your baked goods. For those who are unaware, this means they are unprocessed and unwashed which is what you want in poppy seeds. Don't return the bags if you find plant matter in your seeds, it's normal! They retain an earthy, bitter, nutty flavor and taste way better than the processed/already washed stuff. It makes the difference between an "okay" muffin and a "great!" muffin.
