REGISTRATION:

Spouse registration is intended for family members who are not employed by the company or active in the business. Family members or quests active in the spice trade must submit the full member or non-member registration fee.

CANCELLATIONS:

All refund/cancellation requests must be received in writing. Cancellations received on or before March 5, 2020 will receive a full refund less \$35 processing fee. Cancellations received March 6, 2020 through March 19, 2020 will receive a 50% refund less \$45 processing fee. Cancellations received after March 19, 2020 will not be issued a refund. All refunds will be processed after April 23, 2020.

SUITCASING POLICY:

ASTA shall have a zero tolerance policy for suitcasing at the ASTA Annual Meeting or any other ASTA event. Suitcasing is the practice in which companies gain access to an ASTA event, typically by either registering no company employee for the event or registering only one or some company employees for the event, and then such company representatives hold competing events or conduct business with legitimately registered event attendees at the event venue, whether in reserved venue space such as a hotel room or in other public spaces at the event venue. Violators may be subject to the potential penalties as outlined in the ASTA Suitcasing Policy, available at www.astaspice.org
