

- World's biggest lockdown 1.3 Billion People
- Doubling rate has slowed down to 12 days
- ➤ Recovery Rate increased from 13% to 25%
- Lower fatal cases

LOCKDOWN 1.0

- 21 days (March 24th to April 14th)
- Clear guidelines
- Travel & transportation ban



LOCKDOWN 2.0

- 21 days (April 15th to May 5th)
- Substantial increase in testing
- Agriculture & food transportation eased



LOCKDOWN 3.0

- 14 days (May 5th to May 17th)
- Districts across India classified as Red, Orange and Green



March to April: Peak arrival period for most Spices in India.

Activities back on track, after initial slowdown, with easing of restrictions for agriculture.

CROP UDATE MAY 2020 - CHILLI






Update:

- \triangleright Crop is at **final stage of harvest** and ~90% of the harvesting has been completed.
- > Labor Availability and cost a challenge to the farmer
- > Farmers moved **produce to cold storages** in anticipation of price hike in the coming months
- China commenced sourcing of high heat Chilli from India , during April 2020 pushing up demand & prices
- > Domestic buyers are sourcing on a low key expected to scale up post lifting of lockdown
- > Exporters have entered the market late sourcing critical requirements through suppliers


CROP UDATE MAY 2020 - TURMERIC



Update:

- > Over-all production decreased by ~3%; carry forward stocks increased by ~19%; overall supply similar to 2019
- > Post harvest activities in progress. About 75% of the production still held by farmers.
- > All **major markets closed** due to lockdown; few markets in Maharashtra and Tamil Nadu opened post 20th April
- Prices running at 6 year low future crop?

CROP UDATE MAY 2020 - CUMIN



Update:

- > IPM crop is limited in volume; coupled with issues pertaining to locust attack; prices expected to remain firm
- > Purchases of new crop impacted from March'20; **farmers holding stocks**; farm gate purchases continuing
- > Local Government Tax @ 2% will push prices up

Transportation Restrictions - Challenges for interstate and intrastate movement



Movement of **essential commodities permitted** by Government



Labor - Movement restrictions along with exodus of migrant workers - impact on farming and manufacturing



Local as well as in-house labor being engaged for smooth continuity of operations



Courier Services - Services temporarily halted impacting dispatch of samples and shipping documents



Workaround - self certification approval & telex release of documents



Port Operations - Issues with container availability and shipping line connectivity



Resumption of normal operations - container terminals, authorized customs clearing & forwarding agents

CONTINUITY WITH CAUTION



✓ Government has been working on major Agri reforms such as e-sourcing and e-marketing

✓ Government has classified Spices under "**essential foods**", permitting continuity of all operations

Spices Board - Circular for exemption of Spices Board sampling and stuffing requirement for countries where certificate is not mandatory.

Port Operations - Operations of container terminals, functioning of authorized custom clearing & forwarding agents are being allowed under restrictions as proposed by local authorities

Country of Origin (COO) Certificate - Now available online, reducing lead time

Post Covid India to emerge as a stronger source of Spices Supply with Agri & Economic reforms

COVID LOCKDOWN - KEY ACTIVITIES IN SPICES INDUSTRY



Procurement

- ✓ Leveraging direct farmer linkages farm-gate sourcing of Spices
- ✓ Adherence to Government norms
- ✓ Hygiene and safety



Manufacturin a

- ✓ Operating within approved norms for food processing industry
- ✓ Scanning and health check of workers and other staff
- ✓ Health, hygiene and safety norms



Logistics

- ✓ Continuity of shipments working out options with shipping lines;
 alternate ports / routing
- ✓ Normalcy expected by June 2020

ITC SPICES - SOME KEY INTERVENTIONS



Statutory Approval

- Approval for continuity of operations farm gate sourcing ,pre-processing ,factory ,lab & transportation
- **Permission** from local authorities for people movement



Safety & Hygiene

- Safety task force
- Compulsory use of masks, infrared thermometers and hand sanitizers
- Safety training to all staff; periodic updates and health checks
- Social distancing at people assembly points, entry and work areas



Welfare

- Stay arrangements made within factories for key personnel
- **Recognition** of individual and team efforts in these difficult times; incentives
- Advisory for self and family care; emergency procedure SOP



Social Responsibilit y

- Significant contribution to the Prime Minister's relief fund; Provincial Government funds
- **PPE for health and sanitary personnel** in all operating locations
- Sanitisation tunnels and health check booths.
