### Organic Spices = No Chemical Inputs

- Land must be in transition for 3 years
- Documentation assuring no chemical inputs verified by a 3<sup>rd</sup> party (certifier)
- No chemical fertilizers, herbicides or insecticides permitted



#### Sustainable Agriculture

Sustainable agriculture methods are mandatory

- Replanting
- Terracing
- Selective Harvesting
- Intercropping
- Manual Weed Control
- Buffer Zones



### **Traceability & Transparency**

Organic certification requires a formal Internal Control System (ICS) to assure full lot traceability back to the farmer and transparency of records

- Supply Chain Sensitivity Any break in the supply chain's integrity can nullify a product's organic certification

## Impact on Customers' Buying Practices

Systemic issues in purchasing organic spices:

- Economies of Scale Organic spices remain a small percentage of the total spice market
- Supply Chain Sensitivity Any break in the supply chain's integrity can nullify a product's organic certification
- Supply/Demand Supply/Demand conditions can rapidly change in a niche market (i.e. Alar & Mad Cow!)

## Keys to Successful Organic Procurement

- Evaluate your suppliers on more than just price
- Secure contracts whenever possible to reserve supply
- Coordinate purchasing with farmers' cultivation plans and harvest schedules
- Provide adequate lead time and/or maintain higher safety stocks —
   "Just in Time" is difficult with organic spices

## Keys to Successful Organic Procurement

- Communicate any changes to your suppliers, such as requirements, timelines, volumes, specifications, etc.
- Work with your suppliers to create "win-win" business propositions on shipment size, terms of sale, and secured lots
