#### **REGISTRATION DEADLINE**

Advance registration ends Friday, April 12, 2024. After that date, you must register onsite at the event.

#### CANCELLATIONS

All refund/cancellation requests must be received in writing. Cancellations received on or before March 5, 2024, will receive a full refund, less the \$45 processing fee. Cancellations received March 6 – April 12, 2024, will receive a 50% refund. Cancellations received after April 12, 2024, will not be refunded. Refunds for payments made via check or wire will be processed after the event.

#### SUBSTITUTIONS

Attendee substitutions may be made at any time before the event, provided the substitute is from the same organization.

#### SUITCASING POLICY

ASTA shall have a zero-tolerance policy for suitcasing at the ASTA Annual Meeting or any other ASTA event. Suitcasing is the practice in which companies gain access to an ASTA event, typically by either registering no company employee for the event or registering only one or some company employees for the event, and then such company representatives hold competing events or conduct business with legitimately registered event attendees at the event venue, whether in reserved venue space such as a hotel room or in other public spaces at the event venue. Violators may be subject to the potential penalties as outlined in the ASTA Suitcasing Policy, available at www.astaspice.org.
