## REGISTRATION POLICIES

---

### HEALTH & SAFETY

The health and safety of our attendees is important to ASTA. Final detailed health and safety plans will be communicated closer to the event, but attendees should expect the following:

- Attendees are strongly encouraged to be vaccinated for COVID-19
- Face masks may be required, regardless of vaccination status
- Hand sanitizer and face masks will be available to all attendees

In addition, you may see setup and service modifications such as attended buffets instead of self-service, or more distanced seating during the meeting.

***Health and safety measures implemented by ASTA prior to the event or onsite are subject to change based on local, state, or federal guidelines and/or current conditions at the time of the event. Any violations of the health and safety measures may result in prohibiting entry to, or removal from, the event.***

### REGISTRATION DEADLINE

Advance registration ends Friday, April 1, 2022. After that date, you must register onsite at the event.

### CANCELLATIONS

All refund/cancellation requests must be received in writing. Cancellations received on or before February 25, 2022 will receive a full refund less \$45 processing fee. Cancellations received February 26 – March 11, 2022 will receive a 50% refund. Cancellations received after March 11, 2022 will not be issued a refund. Refunds for payments made via check or wire will be processed after the event.

### SUBSTITUTIONS

Attendee substitutions may be made at any time prior to the event, provided that the substitute is from the same organization.

### SUITCASING POLICY

ASTA shall have a zero-tolerance policy for suitcasing at the ASTA Annual Meeting or any other ASTA event. Suitcasing is the practice in which companies gain access to an ASTA event, typically by either registering no company employee for the event or registering only one or some company employees for the event, and then such company representatives hold competing events or conduct business with legitimately registered event attendees at the event venue, whether in reserved venue space such as a hotel room or in other public spaces at the event venue. Violators may be subject to the potential penalties as outlined in the ASTA Suitcasing Policy, available at [www.astaspice.org](http://www.astaspice.org).

### PHOTO/FILM POLICY

ASTA may take photographs or film the trade show and other areas of the event. By participating in the event, you authorize ASTA, without limitation, the right to reproduce, copy, exhibit, publish or distribute any such film or photograph, and waive all rights or claims you may have against ASTA and/or any of its Affiliates, Subsidiaries, or Assignees.
